**Thematic horizons for submissions of research papers and presentations:**

**Structure and format of papers:**

The volume of paper should be at least 4 pages, but not exceeding 25 pages of A4 format. Articles must be written in English. Papers should be printed in MS Word, Time New Roman font (size 12), with 1.5 interval. Tables and pictures must be handled with MS Word drawing tools and supported by source references.

Literature references should be placed in the end of paper and strictly follow the required format ([see the sample template](#)). At the end of paper author should precisely specify the following: first name and surname; scientific degree; country of citizenship; affiliated with a given author a research or other organization (company); e-mails (main and alternative); phones with codes (office and mobile); the convenient detailed post address, on which author wishes to receive the publication after printing.

Given publications should have research character and must be based on principles of scientific and a professional ethic.

**Publication fee:**

Participants of BFM SS 2015 do not pay publication fee.

Non delegates can submit research papers to BFM SS 2015. **Accepted article publication fee for non-delegate is 125 Euro**, due to pay only after accepting the paper. Average delivery cost to provide the main author with hard copy makes 10 Euro.
